#### **Election Process**

1. Appointment of Nominations Committee
2. Call for Nominations (Deadline November 18, 2020)
3. Candidate list confirmed and provided to members (November 20, 2020)
4. Election (AGM, November 21, 2020)

#### *General Information related to the election process:*

1. **Call for Nominations:** Closing on November 18, 2020, KSR will invite interested individuals to apply to run in the annual Board of Directors' election. The Call for Nominations will remain open during this period to ensure this information package and the search for new board directors reaches as many potential candidates as possible. In keeping with non-profit governance best practices and KSR Bylaws, please note that nominations from the floor will not be accepted.
2. **Candidate List:** After November 18, 2020 every member will receive an Election Bulletin from KSR, which will list all prospective candidates – both new candidates and directors applying for re-election - who are running in the November 21, 2020 election. The bulletin will contain a biography and statements from each candidate.
3. **Election:** The election will be held during the 2020 Annual General Meeting. Results will be announced immediately. All successful directors will be required to attend a director meeting immediately following the AGM. A further orientation session will be scheduled for new directors.
